## **Lakeview Greening Project**

## GOALS AND OBJECTIVES:

Goal 1: Better engage and connect residents to each other, events, and opportunities in Ohio City. Goal 2: Implement programming that promotes community pride, shared voices, and environmental health.

Goal 3: Improve physical connections to neighborhood assets, amenities, and services.

Residents of Lakeview Estates have expressed a feeling of disconnectedness from the broader Ohio City neighborhood and City of Cleveland for decades. Ohio City Incorporated began working to break down these barriers in 2015 while organizing with residents to prevent a proposed expansion of the Shoreway with new highway infrastructure, which would further separate residents. This work continued in 2016 with a \$250,000+ investment from the Cleveland Foundation into public art strategically installed to visually break down those barriers, bring residents from both sides of the Shoreway together, raising morale, and turning the wall that divided the community into something residents can be proud of.

With the trail investments taking place and the momentum from the previous two years, OCI developed a series of monthly programs that engaged residents while building trust between residents and the organization. OCI partnered with Trust for Public Land and developed programming around the trail network and greenspaces. Some examples included community cleanups, tree plantings, bike education with youth, a scavenger hunt on the trails, a mural installation on the trail.

This project was innovative because it allowed us to engage with residents over time, talking about issues that impact them like poor air quality, truck traffic, and crime in a holistic way, rather than around specific projects, which is traditionally how residents have engaged with organizations like ours. It also allowed us to build trust and meaningful relationships with the residents, which is really important in communities like Lakeview Estates where residents feel exploited by organizations coming into their community to do a project or to get grant funds, and often don't deliver on the promises they've been told. We intentionally created small accomplishments or "leave behinds" during each of the monthly programs, such as a mural, bike racks designed by youth, and trees, to demonstrate to residents that we are committed to them and will deliver on the things we say we will.

## **Lakeview Greening Project**

This program was unique because it focused on building relationships with residents. We hosted programming with residents monthly for 18 month with a focus on building trust with community members and listening and learning about their experiences, concerns, and improvements they would like in their neighborhood. Benefits, Goals and Results: The goal was to build trust with community members; to ensure Lakeview Estates residents knew the trails were for them to use; increase physical activity and trail use; to connect residents to nature; to leave behind small improvements each month (public art, bike racks, plants) as a way of building trust and demonstrating that we're committed to helping make change. Transferability: This is a model that could be replicated in many different communities.
